SECTION 4: FIRST AID MEASURES

4.1 Description of first aid measures:

Request medical assistance immediately, showing the SDS of this product.

By inhalation:

Remove the person affected from the area of exposure, provide with fresh air and keep at rest. In serious cases such as cardiorespiratory failure, artificial resuscitation techniques will be necessary (mouth to mouth resuscitation, cardiac massage, oxygen supply, etc.) requiring immediate medical assistance. Heating can release hazardous gases, nitrogen oxides (NOx), avoid exposure.

By skin contact:

Remove contaminated clothing and footwear, rinse skin or shower the person affected if appropriate with plenty of cold water and neutral soap. In serious cases see a doctor. If the product causes burns or freezing, clothing should not be removed as this could worsen the injury caused if it is stuck to the skin. If blisters form on the skin, these should never be burst as this will increase the risk of infection.

By eye contact:

By ingestion/aspiration:

Request medical assistance immediately, showing the SDS of this product. Induce vomiting (ONLY IN CONSCIOUS PEOPLE!) and then ingest large quantities of liquid to dilute the toxin. Keep the person affected at rest.

4.2 Most important symptoms and effects, both acute and delayed:

Exposuring to Nitrogen oxides (NOx) may cause symptoms of poisoning after several hours. Keep under medical supervision for at least 48 hours.

SECTION 5: FIREFIGHTING MEASURES

5.1 Extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use. SECTION 6: ACCIDENTAL RELEASE MEASURES
